New Member Education consists of three modules referred to as Session A, Session B and Session C, each of which is two hours. In addition, you must attend "hands-on" training specific to working in the THRIFT HOUSE Retail store and in Operation School Bell; these sessions will be conducted by ladies in charge of those areas. The THRIFT HOUSE training is approximately five hours and Operation School Bell® training is approximately four hours. Training for working Toy Cart at Dell Children's Hospital includes required training by the hospital as well as training with Toy Cart Day Chairs.

After the completion of all training you will choose one THRIFT HOUSE assignment and possibly another assignment, depending on your interests, and begin what we hope will be a wonderful volunteer experience for you!
